

CHILD ABDUCTION

PLEASE HELP!

Aela Anne Rose Boyd (aged 2 3/4 years) while living happily with her father William Boyd (her sole carer for 3 years – all her life) was criminally and cruelly abducted by two strangers on 15th November 2002 during an access visit. She was then taken 350 miles from her friends, home and the only parent she had ever known. She was simply locked away with people she had neither trust nor attachment to and of whom she was frightened.

The abduction was executed by a network of corrupt members of Scottish authorities and although completely illegal and against a court agreement that she would be returned home to my care the next evening, nothing was done.

The abducting party's association with Scottish Authorities enabled this illegal cruelty and abuse to take place. (Ref: See Nancy Falconer: Parent Child Abduction is Child Abuse). The Sherriff involved, before having heard any evidence, broke every law concerning Children's Rights and Child Protection and left the child screaming and crying for her daddy and to go home for 3 months without a visit from anyone familiar to her. In the course of 2 years he ignored all evidence presented to him including a child psychologist report testifying to the child's suffering and the need for her to come home "at the earliest opportunity".

Abusing his position, he maliciously attempted to bribe the father with contact in exchange for custody to the abductors, one of whom is employed by Highland Social Services.

This department, ignoring their duty and remit, has throughout conspired to falsify and manufacture information to assist a colleague in the abuse of a young child. The police were immediately contacted at the time of the abduction, but were told by their Chief Constable to turn a blind eye.

Both Aela and her father were later wrongfully arrested and incarcerated at a police station for 8 hours, which badly traumatised Aela, due to police in the Northern Constabulary falsifying information.

Aela has since reported physical suffering and has been denied contact with anyone she loves and is simply left to suffer. Although very blatant child abuse, the authorities involved have it in their interests to do nothing. This abuse has continued for now over 3 years while Aela (now 6 years old) is being systematically brainwashed and intimidated to say the right things and is bullied to act like she is happy.

Any attempt to help Aela by way of inquiry, investigation or fair, just treatment has been fervently resisted by the agencies guilty of this abuse. The cover up of the degree of nepotism and corruption, which seems to permeate these departments, continues.

It is now almost 2 years since Aela has seen or spoken with anyone familiar to her prior to her abduction. She is effectively imprisoned and denied her most basic rights to contact. This serves to prevent any evidence of Aela's suffering coming to light. She has also reported being physically abused by her mother's stepfather, Eric Carbarns (a corrupt employee of Highland Social Services). Although Highland Social Services have a very clear duty to remove the conflict of interest which exists, no steps have been taken to resolve this. Nor has the abuse of Aela ever been properly or objectively investigated.

We now appeal to anyone in or outside Scotland who cares about Child Safety, Child Protection and basic human rights to take whatever action possible to help an innocent child illegally and criminally abducted and abused.
