

31/1/06 Child Abduction, Child Cruelty and Corruption ^{31/01/}

I am here to report the abduction and abuse of my daughter Aela Anne Rose Boyd (D.O.B. 06/02/00), who was criminally abducted from her home, friends and only carer she had ever known. This was effected by various acts of criminal misconduct and negligence by a network of people within Scottish Authority. On 15TH NOV 2002, Aela was illegally abducted by two people she did not know, trust or want to be with. Although a court agreement was in place stating Aela would be returned to her home the following evening after an access visit. The court used deception to assist this abduction and cruelty before any evidence had been led, Aela was then left without contact or access, locked up with strangers, while the court attempted to bribe the resident parent and only main attachment figure to force an outcome for the abducting party. The police involved were contacted immediately at the time of abduction, but were told by their senior officer to allow this abuse to take place. Aela was then left screaming and crying to come home for a period of 3 months with no contact with anyone familiar to her in a strange and unfamiliar environment with strangers. Although this is a crime against a child, it has been sustained through the involvement of various members of Scottish Authority including corrupt social workers pervert the course of justice through various acts of nepotism.

Although this is very blatant child abuse/cruelty and against international law and national law on child protection (SEE NANCY FALCONER: PARENTAL CHILD ABDUCTION IS CHILD ABUSE), this abuse and denial of rights has continued through the degree of nepotism, conflict of interests and lack of accountability for corrupt social workers (conflict of interests), Police (wrongful arrest - child incarcerated for 8 hrs) and abuse of position, professional negligence, professional misconduct, and criminal actions of members of Judiciary. Aela has also reported being physically/sexually abused by her paternal grandfather and is witnessed physically suffering severe physical distress (not investigated due to nepotism and conflicts of interest within social services, Police and Judiciary). The manufacturing of false information (and abuse of human rights) has also continued in order to attempt to conceal the crimes and abuses of Aela Boyd by members of Scottish Authority. Although Aela has constantly cried to come home (said she is taken into grandad's bed and kissed on the mouth, told grandad is dressing as a woman, suffered severe constipation and constant ill health, was illegally removed from her home and denied the most basic contact rights, been witnessed to be suffering emotionally and psychologically by a child psychologist, the concerted efforts of

conceal these crimes against a child,
her main attachment figure and the public
interest have remained uninvestigated and
unpunished. Aela has now been denied all
contact with anyone familiar to her prior
to her abduction for over 1 1/2 yrs. She has
also been denied all telephone contact (3YRS)
to conceal her suffering and prevent her being
able to give any evidence of the abuse she
is suffering. She has also reported being
bullied and intimidated to behave like she
is happy and say what she is told to say
by her abductors and abusers. I have also
been contacted by a social worker who worked
previously in the area where Aela was illegally
removed to and is wrongfully held in, who has
informed me of a network of people within
Scottish authority who are abusing children
then using their positions to cover up these
crimes. Although this has been reported to police
and other agencies, the cover up of crimes against
Aela Boyd continues. Members of Parliament seem
to be involved also in covering up these crimes
as there is now so many members of Scottish
authority involved. Aela continues to suffer and
continued to be denied her rights to come home and have justice
