LETTER FROM William Boyd (Aela's Father) to H.M.I.C

Dear Sir/Madam

I, William Boyd, am the father of Aela-Anne, R. Boyd DOB 6/02/00, and am writing concerning the actions and negligence of several policemen in and around the Dingwall area. Firstly, it must be understood, I have been the sole carer of my daughter since she was 3 months old, until she was 2 ³/₄ years, when she was cruelly abducted by a mother she did not know or trust (having only met her seven times). I am effectively my daughter's 'mother figure'. On 15TH NOV 2002 my daughter was not returned after an access visit. Although I reported this to the police I was told it was a civil matter, and should be resolved by the courts. My daughter was then locked up in a house for 3 months without being taken out and denied all contact by telephone or otherwise. (The family being afraid I would take my little girl home). Eric Corbarns, the mother's step father, is a social worker with Highland Council and pre-meditated and planned with a friend and colleague working in the same office to write a false letter to be presented to the court to support this abduction and cruelty to a innocent child. Surely a terrible abuse of position in an attempt to pervert the course of justice. I, and many others, consider the subsequent treatment of my daughter and myself to be negligent in the extreme, by the court, local social services and the police. After 3 months of my daughter being left with no contact with anyone familiar to her, I was eventually granted a visit. The Sheriff granted the mother interim residency against my consent. The child's mother has also admitted in court of having thoughts of sexually abusing our daughter. Prior to this, my daughter had never been away from myself (for more than 2 days in her young life). After seeing my daughter after this 3 month separation, I was both shocked and horrified at the condition of trauma she was in. I then determined to seek medical help for her, and asked a close friend, Nicholas Briggs to contact the Dingwall police and inform them that my daughter was safe and that I would not be returning her to her mother's family and would be approaching the court

What was initiated over the next two days by the police in Dingwall fabricating information, is quite unbelievable. On Tuesday ^(18TH FEB 03) morning 10 A.M, I was arrested along with my daughter on a charge of Plagium. Even though any policeman should know that a charge of Plagium cannot be brought against a concerned parent who has legal Parential Rights. This arrest caused my daughter massive trauma as we were held in the police station in Newton Stewart for over six hours. It is understood that the police in Dingwall said that I was leaving the courts with my daughter, even though no-one had said this, and this would be a matter for the civil courts. It is understood that five different Police forces were involved in this nationwide man-hunt for me and my daughter (who was very happy to know her home and friends still existed). On the telephone I had mentioned a friend's name (before the arrest). The house that she had not lived in for over one year was invaded and turned over at 4-00 AM in the morning. They have many young children in this community home who were caused considerable distress. Friends in Grampian were visited, as were friend and family in Glasgow and Galloway. My daughter was then taken away for the second time causing her further trauma. Upon seeing my doctor on TUE 18TH FEB 03 he immediately recommended to the court that she see a child psychologist. Due to the Dingwall police lying and concocting a charge simply to ensure my daughter is kept in an area where the local authorities can be influenced by Eric Carbarns (mother's stepfather + social worker) and whoever it is within the Dingwall Police who are assisting them. This charge, of course, was subsequently dropped by the Procurator Fiscal. I was wrongfully arrested and serious emotional and psychological damage was done to my daughter (3 YRS) who had already suffered being locked up for 3 months with strangers. Although I have tried on many occasions to report several crime I am told more or less to go away by the Police. During one contact I was told by my daughter that the mother's step father is taking her into his bed and kissing her on the mouth. Again I am told that one Inspector Ahnsholm decided not to investigate. I have tried to report without success:

- 1) PLAGIUM - ERIC CARBARNS
- 2) CHILD CREEPLY - ERIC CARBARNS / IONA CARBARNES
- 3) PERVERTING THE COURSE OF JUSTICE - ERIC CARBARNS / ALAN M'FADYEN
- 4) WRONGFUL ARREST - CHARGE OF PLAGIUM
- 5) ABUSE OF A CHILD - ERIC CARBARNS (NOT INVESTIGATED)

I also know the Carbarns family have friends within the Police Department locally. I now Iona Carbarns is friendly with a policeman called Dougie who lives in Rain - Ork, as I have wondered who might be influencing things within the Police for this well and dysfunctional family.
